Online Safety & Communication

POLICY

Introduction

In today's digital age, online communication has become an integral part of our daily lives. At our sports club, we recognize the importance of online communication for staying connected, sharing information, and promoting our activities. However, we also recognize the potential risks and challenges that come with online communication, including cyberbullying, online harassment, and other online safety concerns.

To ensure that our online communication is safe, secure, and responsible, our sports club has developed an Online Safety and Communication Policy. Policy

- 1. Hazelwood Sports Club values safe and respectful communication both online and offline. We expect all members to adhere to the following guidelines when using the internet or other forms of digital communication.
- 2. Members should use digital communication tools, such as email, social media, and messaging apps, in a responsible and respectful manner. This includes refraining from using abusive language, making threats, or engaging in any other form of harassment or bullying.
- 3. Members should not share personal information, such as home address, phone number, or financial details, with anyone online. This information should only be shared with trusted individuals or organizations through secure channels.
- 4. Members should not share or distribute inappropriate content, such as explicit images or videos, through digital communication tools. This behaviour is not only unacceptable but may also be illegal.
- 5. Members should be mindful of their online activity and how it reflects on the sports club. Any content shared or posted online that may reflect poorly on the club or its members may result in disciplinary action.
- 6. Members should report any suspicious or inappropriate online activity to a coach, staff member, or management immediately. This includes any attempts to contact members for suspicious reasons, such as phishing or fraud.
- 7. Hazelwood Sports Club reserves the right to monitor all online activity related to the club, including social media, email, and messaging apps. This is to ensure that members are adhering to the guidelines outlined in this policy.
- 8. Members should only communicate with other members or coaches through official channels provided by the club. This includes email addresses, messaging apps, or social media accounts that are specifically designated for club communication.
- 9. Any communication between coaches and minors must be done in a professional and appropriate manner. Coaches should not engage in any form of inappropriate behaviour or communication with minors, including any behaviour that could be perceived as grooming.
- 10. Any violation of this policy may result in disciplinary action, up to and including suspension or termination of membership. We are committed to creating a safe and respectful environment for all members, both online and offline.
